A local law Imposing A Limitation On The Number Of Consecutive Terms To

Be Held By Members Of The Clinton County Legislature

Be it enacted by the Clinton County Legislature of the

SECTION 1. LEGISLATIVE INTENT. It is the intent of the within local law to limit the number of consecutive terms to be held by any member of the Clinton County Legislature so as not to exceed twelve (12) consecutive years.

SECTION 2. Commencing with the January 1, 1998 term, no person shall be elected to serve as a member of the Clinton County Legislature for a period exceeding twelve (12) consecutive years as computed below.

SECTION 3. COMPUTATION OF TERMS OF OFFICE. Computation of the twelve (12) year period shall commence with that term of office first following election. Service rendered during an appointed term shall not be applicable.

No person shall be precluded from finishing a term of office during which the twelfth (12th) consecutive year shall occur one year or more after assuming office. Said individual shall be permitted to finish his/her term of office despite the twelfth year occurring during his/her term of office.

Computation of the number of consecutive terms shall commence with the term of office following the general election to be held in November, 1997 or any general or special election held thereafter. Service in a current term of office shall not be computed.

SECTION 4.        EFFECTIVE DATE. This Local Law shall become effective only if approved by the affirmative vote of a majority of the qualified electors voting upon the Local Law at the general election to be held in November, 1996. If so approved, it shall become effective immediately.

BE IT FURTHER RESOLVED, that the Clerk of this Legislature shall transmit the form of the proposition, which shall contain a brief statement of the text of said Local Law and its number, to the Clerk of the Board of Elections. Thereafter, a sufficient number of copies of such proposition and abstract shall be printed and made available to the electors at the time of registration or otherwise in advance of election, and in addition, a sufficient number of copies shall be delivered with other election supplies, and distributed to the electors at the election, and in the event the local law is approved by an affirmative vote of the majority of the qualified electors voting upon the local law at the general election held in November, 1996, the Clerk of this Legislature be, and the same hereby is, directed to renumber same as the appropriate local law of the Year 1996.
