**SECTION 1.** Pursuant to Section 73 of the Workmen's Compensation Law, the County Self-Insurance Plan enacted by Local Law #1 of 1956 is hereby abandoned as of midnight, December 31, 1965.

**SECTION 2.** The County Self-Insurance Plan provided pursuant to Local Law #1 of 1956 shall continue to operate until all liabilities of the plan incurred prior to such effective date shall have been satisfied and all advances to the County Self-Insurance Fund shall have been repaid.

**SECTION 3.** At such time as all advances and liabilities have been closed out, any assets remaining shall be paid to the participating municipality as provided in Local Law #2 of 1956.

**SECTION 4.** This law shall take effect midnight, December 31, 1965 after a public hearing and approval of the Chairman of this Board pursuant to Section 3 of the General Municipal Law and Section 73 of the Workmen's Compensation Law.
