Stenographer's minutes of the Regular Session of the Clinton County Legislature held Wednesday, January 11, 2017 in the Legislative Chambers, 137 Margaret Street, Plattsburgh, New York.

James Coffey, Esq., County Attorney Jeanene Bell, Senior Stenographer Chairperson McManus called the meeting to order at 7:00 p.m.

Following the pledge of allegiance to the flag, County Administrator Michael Zurlo conducted roll call. All Legislators were present.

Legislator Dyer motioned to accept the minutes of the December 28, 2016 Regular Session and the January 4, 2017 Organizational Meeting, seconded by Legislator Keenan. Carried (10-0-0).

Chairperson McManus reported there is a public hearing regarding a grant award received from the New York State Housing Trust Fund Corporation Office of Community Renewal. Chairperson McManus asked the Clerk of the Board to read the notice of public hearing.

Legislator Conroy motioned to open the public hearing at 7:01 p.m., seconded by Legislator Rosenquest. Carried (10-0-0).

Chairperson McManus asked if anyone present wished to address the board regarding this grant award.

Rodney Brown, the Deputy County Administrator, reported the grant (in the amount of \$435,000) was received through the Community Development Block Grant Program from the New York State Office of Homes and Community Renewal. The grant was administered by The Development Corporation under contract with Clinton County to provide financial assistance for new employee training for SpencerARL as the business expanded its operations. Since the award of the grant, the company hired 165 employees, more than doubling their workforce. There were 113 employees who met the threshold for low and moderate income in compliance with the grant requirements. SpencerARL accomplishes contract work for Novabus and Prevost.

There being no further speakers, Legislator Rosenquest motioned to close the public hearing at 7:05 p.m., seconded by Legislator Keenan. Carried (10-0-0).

There being no one further who wished to address the Legislature, Chairperson McManus moved on to Committee Reports.

Legislator Dame thanked those colleagues who took that bold and futuristic move with the Airport. He thanked former Legislators Robert Heins, Sara Rowden, James Langley, Jr. and Keith Defayette, along with Mr. Brown, Mr. Zurlo and Chairperson McManus.
