Jacqueline Kelleher, Esq., County Attorney John Kanoza, Director of Public Health Chairperson Henry called the meeting to order at 5:15 p.m.

Following the pledge of allegiance to the flag, Michael Zurlo, the County Administrator, conducted roll call. All legislators were present.

Legislator McGill motioned to accept the minutes of the August 26, 2020 Regular Session, seconded by Legislator Peryea. Carried (10-0-0).

Chairperson Henry asked if anyone wished to address the Legislature.

There being no one who wished to address the Legislature, Chairperson Henry moved on to Committee Reports.

Buildings and Grounds Committee - Legislator Peryea

Legislator Peryea reported the Buildings and Grounds Committee meeting scheduled for Monday, September 14th was cancelled.

The next meeting is tentatively scheduled for Thursday, October 8th at 4:30 p.m.

Children and Family Services Committee - Legislator Potiker

Legislator Potiker reported the Children and Family Services Committee meeting scheduled for Monday, September 1st was cancelled.

The next meeting is tentatively scheduled for Tuesday, October 6th at 5:15 p.m.

Economic Development and County Operations Committee - Legislator Rosenquest

Legislator Rosenquest reported the Economic Development and County Operations Committee meeting scheduled for Tuesday, September 8th was cancelled.

The Committee was polled on Resolutions #535 and #547 under Waive Rule 13.2. Resolution #536 was withdrawn.

Finance Committee - Legislator Timmons

Legislator Timmons reported the Finance Committee met Wednesday, September 2nd.

Kimberly Davis, the County Treasurer, reported that this year, pre-COVID, the County was \$1.4 million above projected revenue but receipts continue to decline each month. The County has decided to reduce its sales tax by 9 percent from last year. All towns and villages have been contacted to let them know the estimated reduction in sales tax for 2021 so that they can start preparing their budgets. We are continuing to watch and prepare for anticipated state aid reductions.

Representatives from the North Country Chamber of Commerce were present to discuss the 2021 Marketing Plan, and representatives from Clinton Community College were present to discuss the 2020-2021 budget request.

Resolutions #504 through #506 are included on the agenda.

The next meeting is tentatively scheduled for Wednesday, October 7th at 6:15 p.m.

Health Committee - Legislator Waldron

Legislator Waldron reported the Health Committee met Tuesday, September 1st at 4:30 p.m.

John Kanoza, the Director of Public Health and Richelle Gregory, the Director of Community Services, were present to discuss Resolutions #507 through #512 on the agenda, and the Committee was polled on Resolution #513.

The next meeting is tentatively scheduled for Tuesday, October 6th at 4:30 p.m.

John Kanoza, the Director of Public Health, provided an update on the COVID-19 Pandemic. Mr. Kanoza reported currently, there are 0 active cases. There have been 153 positive lab-confirmed cases to date with 149 recovered. The big challenge now is school openings. The Health Department continues to wait for guidance from New York State.

Legislator Rosenquest thanked the Health Department staff for assisting a local downtown gym in reopening.
