## AWARDING BID FOR CONSTRUCTION OF LIGHT INDUSTRIAL MANUFACTURING FACILITY PROJECT – PLATTSBURGH INTERNATIONAL AIRPORT

WHEREAS, Resolution #200 dated March 8, 2017 accepted the New York State Department of Transportation (NYSDOT) Grant in the amount of \$38,045,000 for the Upstate Airport Economic Development and Revitalization Grant Program; and

WHEREAS, this Grant program includes the Upstate Airport Initiative (UAI) Projects consisting of: demolition of eight (8) abandoned buildings, construction of four (4) new buildings (Air Cargo Receiving and Distribution Center (RDC) facility, General Aviation Federal Inspection Station (FIS)/Customs and Border Protection facility, Light Industrial Manufacturing Facility and a Multi-Modal Public Transit building); and renovation of seven (7) buildings; Rehabilitation of Central Terminal Parking Lot; Terminal Building Concession Space Build-Out; FIS Boarding Bridge Construction; and Development of Access Road and Parking for Retail Business Site; and

WHEREAS, Resolution #408 dated May 25, 2017 authorized the County Treasurer to establish the Light Industrial Manufacturing Facility Project in the amount of \$11,650,950; \$8,650,950 to be funded by the Upstate Airport Economic Development and Revitalization Grant Program and \$3,000,000 to be funded by a contract with The Development Corporation, and

WHEREAS, Resolution #597 dated August 9, 2017 authorized a Project Labor Agreement (PLA) as negotiated with the labor unions to be included in the UAI Projects; and

WHEREAS, Resolution #667 dated August 23, 2017 authorized the Purchasing Agent to solicit bids for the UAI Projects, including County Project 17-06 Light Industrial Manufacturing Facility Project; and

WHEREAS, bids were opened for this Project on December 21, 2017 and submitted as follows:

WHEREAS, Luck Brothers, Inc. included an exception in their bid proposal whereby, if found to be the apparent low bidder, they would not agree to be bound by the provisions of the PLA; and

WHEREAS, the bids have been reviewed by the County Attorney and found to be legally sufficient with the exception of the bid from Luck Brothers, Inc. due to the PLA exclusion; now, therefore,

WHEREAS, the Airport Manager recommends Clinton County enter into an agreement with Murnane Building Contractors, Inc. to provide construction services for this Project, contingent upon NYSDOT approval of the Minority-Owned Business Enterprise (MBE) and Women-Owned Business Enterprise (WBE) plan provided; now, therefore,

BE IT RESOLVED, the Clinton County Legislature hereby awards bids to the lowest responsible bidder, Murnane Building Contractors, Inc.; and

BE IT FURTHER RESOLVED, the Clinton County Legislature hereby authorizes the Chairperson to execute all necessary documents for the following:
