WHEREAS, Resolution #757 dated September 12, 2018 authorized the Purchasing Agent to reject bids received for snow plowing for various County buildings and to re-solicit bids based primarily on the apparent cost increase from the previous year; and

WHEREAS, the Purchasing Agent and the Deputy County Administrator have met with the apparent low bidder, Northern Blacktopping, for the original bids and discussed the submission of the bid pricing; and

WHEREAS, it was brought to the County's attention that the bid specifications had changed from last year to this year in reference to the way the bidders can charge the departments (previously charging time from port to port, now charging time for on-site only); and

WHEREAS, with this change in the specifications, the bidders pricing per hour will increase; however, the time they can actually charge the department will decrease, and it is believed that the total amount of monetary change will be insignificant from last year; now, therefore,

BE IT RESOLVED, upon the recommendation of the Finance Committee, through a poll conducted on September 21, 2018, the Clinton County Legislature hereby rescinds Resolution #757 dated September 12, 2018 as stated herein.


