AUTHORIZING THE PURCHASING AGENT TO REJECT BID  
TO ACQUIRE AIRCRAFT RESCUE AND FIRE FIGHTING (ARFF) VEHICLE AND PERSONAL  
PROTECTIVE EQUIPMENT (PPE) PROJECT – PLATTSBURGH INTERNATIONAL AIRPORT

WHEREAS, Resolution #162 dated February 26, 2020 authorized the Purchasing Agent to solicit bids to Acquire Aircraft Rescue and Fire Fighting (ARFF) Vehicle and Personal Protective Equipment (PPE) Project at the Plattsburgh International Airport; and

WHEREAS, the Purchasing Agent opened bids on April 21, 2020; and

WHEREAS, one bid was submitted as follows:

WHEREAS, no bids were submitted for PPE at that time; and

WHEREAS, during the annual Airport Capital Improvement Program review meeting with the Federal Aviation Administration (FAA) in the Fall of 2019, the replacement of the Airport's secondary ARFF vehicle was reviewed resulting in a plan to submit an application for federal grant funding to support this Project; and

WHEREAS, Resolution #365 dated June 10, 2020 authorized the Plattsburgh International Airport to apply for the ARFF Vehicle and PPE Project Federal Grant; and

WHEREAS, a Grant application for this Project was submitted to the FAA on June 11, 2020; and

WHEREAS, upon FAA review of the application, a determination was made that an oversight occurred during the initial review process, and the Airport currently has sufficient ARFF vehicle coverage per federal regulations, and is therefore ineligible for ARFF vehicle replacement; and

WHEREAS, the Plattsburgh International Airport Committee is recommending that the bid be rejected as there is not a need for the ARFF vehicle at this time; now, therefore,

BE IT RESOLVED, upon the recommendation of the Plattsburgh International Airport Committee, at its meeting of September 23, 2020, the Clinton County Legislature hereby rejects the bid received for the Acquire ARFF Vehicle and Personal Protective Equipment (PPE) Project at the Plattsburgh International Airport.
