Notice to Candidates and Party Chairs

This correspondence will serve to advise you that you or your representative may attend any or all of the following Board of Elections activities:

Viewing of the Voting Systems: You will have an opportunity to inspect voting machines and ballot marking devices to be used in the upcoming General Election. You will also be able to witness the conduct of test ballots being cast to confirm the accuracy of the scanner. This pre-election testing will take place beginning on the **23rd of October 2017** at our warehouse on 8 Colorado Road, Plattsburgh AFB. Pre-election testing will continue daily, between the hours of 9:00 A.M. and 5 P.M., until all pre-election testing has been completed.

Re-canvass: The re-canvass of all voting machines will begin on the **8th of November 2017** at our office at 137 Margaret Street, Suite 104, Plattsburgh. This re-canvass will continue daily, with one team conducting the re-canvass, between the hours of 9:00 A.M. and 5:00 P.M., until all voting machines have been re-canvassed.


Post-Election Audit: The post-election audit of randomly selected voting machines will begin on the **17th of November 2017**, at our office at 137 Margaret Street, Suite 104, Plattsburgh, beginning at 9:00 A.M. until 5:00 P.M., until all selected machines have been audited. The drawing, which will select the voting machines that must be audited will take place immediately prior to the audit.


Canvass of Absentee, Military, Special Federal and Affidavit Ballots: the canvass of absentee, military, special federal and affidavit ballots will begin on the **15th of November, 2017**, in the 1st floor Meeting Room in the County Government Center at 137 Margaret Street, Plattsburgh. The canvass of these ballots will continue daily, with one team conducting the canvass, between the hours of 9:00 A.M. and 5:00 P.M., until all ballots have been canvassed.
