Tires: **All tires must have the rims removed prior to disposal at this facility. No Equipment Tires accepted.** Any business / hauler that are required to have a Landfill Permit may also be required to obtain a Part 364 Waste Transporter Permit listing tires as a commodity under certain circumstances. N.Y.S. D.E.C. has a mandatory Recycling Law, effective April 1, 2011 that Prohibits any televisions, computers or computer components from being Disposed of in the landfill.

THEY MUST BE RECYCLED.

Beginning January 1, 2016 Covered Electronic Equipment (CEE) will be accepted with a fee of \$15.00 for any CRT under 19" and a fee of \$27.00 for any over 19". CRT includes the following: **Computers, televisions (including CRTs,)**

*****Small electronic equipment such as the following are also accepted***
VCRs, DVRs, portable digital musical players, DVD players, digital converter boxes, and cable or satellite receivers. Computer peripherals also includes any cable, cord, or wiring permanently affixed to or incorporated into such product. Small scale servers, computer peripherals such as electronic keyboards, electronic mice or similar pointing device, facsimile machines, document scanners, printers.**

All electronics are to be dropped off at the Clinton County Landfills' Cold Storage Building. Your Attendant will direct you to that location.

Faxes, scanners and printers must be devices intended for use with a computer and weigh less than 100lbs.

CFC/Freon containing appliances are \$27.00 each and are to be dropped off at the Clinton County Landfills' Cold Storage Building. Your Attendant will direct you to that location. CFC/Freon containing appliances are: Refrigerators, Freezers, Air Conditioners, Dehumidifiers, and Water Coolers. Any appliance that has Freon is mandated to be serviced for Freon removal, which we can provide on site. It is illegal to dispose of these in the trash.

Propane tanks: 20 lb. cylinders or less, tanks must be empty, and have the valve open & free venting.

CONVENIENCE STATIONS:

There are 12 Convenience Stations located throughout the County that are intended for residential use ONLY.

Disposal fees are based on bag size.

- a.)1-16 gallon size bags are one sticker.**
- b.)17-33 gallon size bags are two stickers.**
- c.)34-50 gallon size bags are three stickers.**
- d.)51-80 gallon size bags are four stickers.**

ALL COMMERCIAL HAULERS, BUSINESSES, LANDLORDS & PROPERTY MANAGEMENT COMPANIES ARE REQUIRED BY LAW TO OBTAIN A HAULERS PERMIT TO USE THE CLINTON COUNTY LANDFILL, AND MATERIALS RECOVERY FACILITY.
