Clinton County District Attorney Andrew J. Wylie announced today that the Clinton County District Attorney's Office, United States Attorneys Office, Essex County District Attorney's Office, the Adirondack Drug Task Force and the New York State Police Troop B Narcotics Task Force conducted a unified law enforcement round up of thirty-one (31) individuals who have recently been indicted by the Clinton County Grand Jury. The following defendants have been arrested this week and have been arraigned already or will be arraigned in Clinton County Court today:

**1. Ryan Z. Smith                      Age 25                      129 Court Street, Plattsburgh, N.Y.**



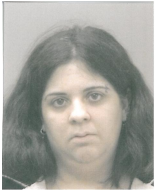

All cases were the result of investigations conducted by the Adirondack Drug Task Force which consists of the Plattsburgh City Police Department, Drug Enforcement Administration, U.S. Border Patrol, New York State Police, Clinton County Sheriff's Department, New York State Police Troop B Narcotics Task Force and the Clinton County District Attorney's Office.
