Clinton County District Attorney Andrew J. Wylie announced today that during the current term of the Clinton County Grand Jury, 32 individuals have been indicted on charges relating to the sale and or possession of controlled substances. THERE ARE THREE INDICTMENTS WHICH REMAIN SEALED UNTIL THE NAMED DEFENDANTS ARE ARRESTED.

All cases were the result of investigations conducted by the Adirondack Drug Task Force which consists of the Plattsburgh City Police Department, U.S. Drug Enforcement Administration, Homeland Security Investigation, U.S. Border Patrol, New York State Police, Clinton County Sheriff's Department, the New York State Police Troop B Narcotics Task Force and the Clinton County District Attorney's Office.
