Clinton County District Attorney Andrew J. Wylie announced that six individuals were arrested today who had recently been indicted by the Clinton County Grand Jury. The following defendants were arrested today and have been arraigned already in Clinton County Court today:

1. Seth I. Adolfsen.

Age 30

Seth I. Adolfsen was arraigned, Monday, April 22, 2013, upon an indictment charging 2 counts of Criminal Sale of a Controlled Substance Third Degree and 2 counts of Criminal Possession of a Controlled Substance Third Degree, all class B felonies, The defendant is alleged to have sold Morphine on September 11, 2012 and October 3, 2012 with each sale taking place in the City of Plattsburgh. Adolfsen subsequently plead

guilty to one count Criminal Sale of a Controlled Substance in the Third Degree with 3 years determinate incarceration and 2 post release supervision. Hon. Patrick R. McGill set bail in the amount of \$20,000.00 cash or \$40,000.00 bond pending sentencing. Adolfsen's case is adjourned for sentencing on June 25, 2013. The defendant is represented by Joe Mucia, Esq.

\$30,000.00 bond. Cator's case is rescheduled for pre trial conference on May 6, 2013. If convicted, the defendant could be sentenced up to 9 years in state prison. The defendant is represented by Heather Maure, Esq.

defendant is alleged to have sold Oxymorphone on December 27, 2012 and Tapentadol on January 8, 2013 with each sale taking place in the City of Plattsburgh. Hon. Patrick R. McGill set bail in the amount of \$5,000.00 cash or \$10,000.00 bond. Good's case is rescheduled for pre trial conference on May 6, 2013. If convicted, the defendant could be sentenced up to 18 years in state prison. The defendant is represented by Heather Maure, Esq.

the amount of \$20,000.00 cash or \$40,000.00 bond. Jessey's case is rescheduled for pre trial conference on May 3, 2013. If convicted, the defendant could be sentenced to up to 18 years in state prison. The defendant is represented by Joe Mucia, Esq.

The defendant is alleged to have sold Heroin on November 26, 2012, in the City of Plattsburgh. Hon. Patrick R. McGill set bail in the amount of \$10,000.00 cash or

\$20,000.00 bond. Kriplin's case is rescheduled for pre trial conference on May 6, 2013. If convicted, the defendant could be sentenced up to 9 years in state prison. The defendant is represented by Heather Maure, Esq.

6. Gerald A. Rabideau

Gerald A. Rabideau was arraigned Monday, April 22, 2013, upon an indictment charging 2 counts of Criminal Sale of a Controlled Substance Third Degree and 2 counts of Criminal Possession of a Controlled Substance Third Degree, all class B felonies. The defendant is alleged to have sold Hydromorphone on January 4, 2013 and January 10, 2013 with each sale taking place in the City of Plattsburgh. Hon. Patrick R. McGill set bail in the amount of \$5,000.00 cash or \$10,000.00 bond. Rabideau's case is rescheduled for pre trial conference on May 2, 2013. If convicted, the defendant could be sentenced to up to 24 years in state prison. The defendant is represented by Heather Maure, Esq.

All cases were the result of investigations conducted by the Adirondack Drug Task Force which consists of the Plattsburgh City Police Department, U.S. Drug Enforcement Administration, Homeland Security Investigation, U.S. Border Patrol, New York State Police, New York State University Police, Clinton County Sheriff's Department, and the Clinton County District Attorney's Office.
