AUTHORIZING CONTRACT WITH MOUNTAIN VIEW PLANNING – PLANNING DEPARTMENT

WHEREAS, the Clinton County Multi-Jurisdictional Hazard Mitigation Plan must be updated every five years to remain eligible for Federal Disaster Assistance and Mitigation Funding; and

WHEREAS, the Clinton County Planning Director has applied for and received a Grant from the Federal Emergency Management Agency for a total project cost of no more than \$100,000 (\$75,000 Federal, \$25,000 County in-kind matching) to complete the five-year update to the Plan; and

WHEREAS, the Clinton County Legislature approved Resolution #339 dated May 8, 2019 which authorized the Purchasing Agent to solicit a Request for Qualifications for the completion of said plan update; and

WHEREAS, Clinton County received five qualification packets from the following vendors with price quotes:

Bold Planning Inc., Nashville, TN - \$45,000
Friends of the North Country, Cadyville, NY - \$65,000
Mountain View Planning, Willsboro, NY - \$75,000
Emergency Preparedness Solutions, Utica, NY - \$72,845
Integrated Solutions Consulting, Inc., Clayton, MO - \$69,978.30; and

WHEREAS, upon review of the proposals, the Clinton County Planning Director contacted Mountain View Planning to discuss their proposal, and he recommends the County enter into a contract with Mountain View Planning for \$70,000 for the completion of the Multi-Jurisdictional Hazard Mitigation Plan; now, therefore,

BE IT RESOLVED, upon the recommendation of the Economic Development and County Operations Committee, through a poll conducted on July 5, 2019, the Clinton County Legislature hereby authorizes the Chairperson to execute all necessary documents for the following:
